AURIGE, the independent leader in heritage restoration and craft trades, has integrated the Paris region-based specialist Parquets GAL into the group.

AURIGE: the independent leader in heritage restoration and enhancement

AURIGE was founded in 1944 under the name Lefèvre by Henry Ménard and Maurice Lefèvre to meet the needs of post-war reconstruction. Today, the company is the only one in France which offers a complete panel of trades dedicated to public and private heritage restoration.

With more than 80 locations, 1,800 employees, and €230 million in revenue, the group embodies the artisanal excellence, combining perfect technical knowledge and artistic flair. AURIGE puts together sculptors, stone masons, carpenters, cabinet-makers, fresco painters, plasterers, ornamentists, wrought iron workers, decorative painters, and consulting engineers, each selected for their expertise and talent.

A forward-looking family group

AURIGE has remained entirely independent and a family-owned led by Marc-Henry Ménard, representing the third generation. The group has doubled its workforce and established itself as a French leader in heritage restoration since the 2000s. It is now positioned as a key player in the very high-end sector, thanks in particular to its ability to deploy comprehensive and coordinated expertise.

Founded in 1999 following the merger of three companies (Gal et Fils, ATS Parquets, and Proparquets), PARQUETS GAL specializes in the installation, maintenance, and renovation of antique parquet floors.

The company serves a clientele of owners or managers of prestigious properties and historic monuments. This premium clientele is half public (town halls, museums, etc.) and half private (foundations, private hotels, etc.).

The company works on all types of projects, from the installation of new parquet floors to the reinstallation of antique parquet floors, including the restoration of old parquet floors, primarily oak. The teams are made up of highly qualified craftsmen, a testament to their expertise and tradition.
